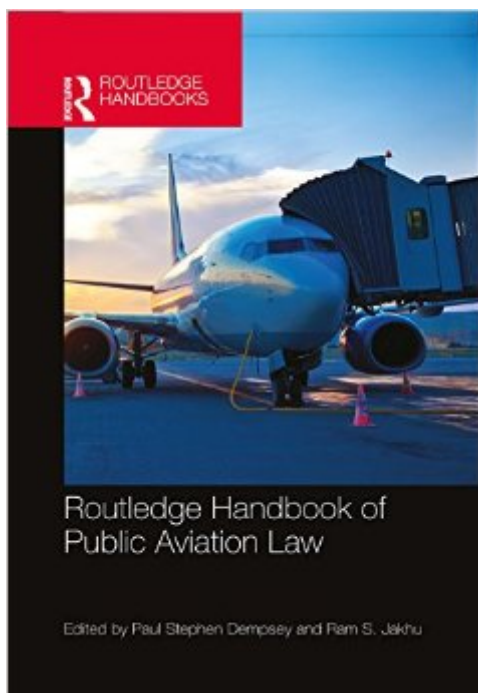

The objective of the book is to identify and summarize existing areas within the context of international research, and to identify and highlight emerging areas.
