

it. The book delves into fair use, familiarity, and basic copyright theory without giving me too much information. It is well-organized and written by an expert in the field. For film and television writers, this book, IMHO, is indispensable.

Great book and helpful information. Only problem is the table of contents didn't make for easy reference (it could have been more detailed by subject and sub-subject). For example, I wanted to find the copyright laws surrounding the non-diegetic use of a cover song in a film. I never did find the answer in this book on that.

After selling that I was a music lawyer and now I do business affairs and project development in films. Michael and Lisa's book is terrific.
